Teachers' Standards

How will they be used?

What are the Teachers' Standards?

- The Teachers' Standards set a clear baseline of expectations for the professional practice and conduct of teachers and define the minimum level of practice expected of teachers in England.
- They were developed by an independent review group made up of leading teachers, head teachers and other experts.

Practising teachers will use the Teachers' Standards to support their own professional development and growth

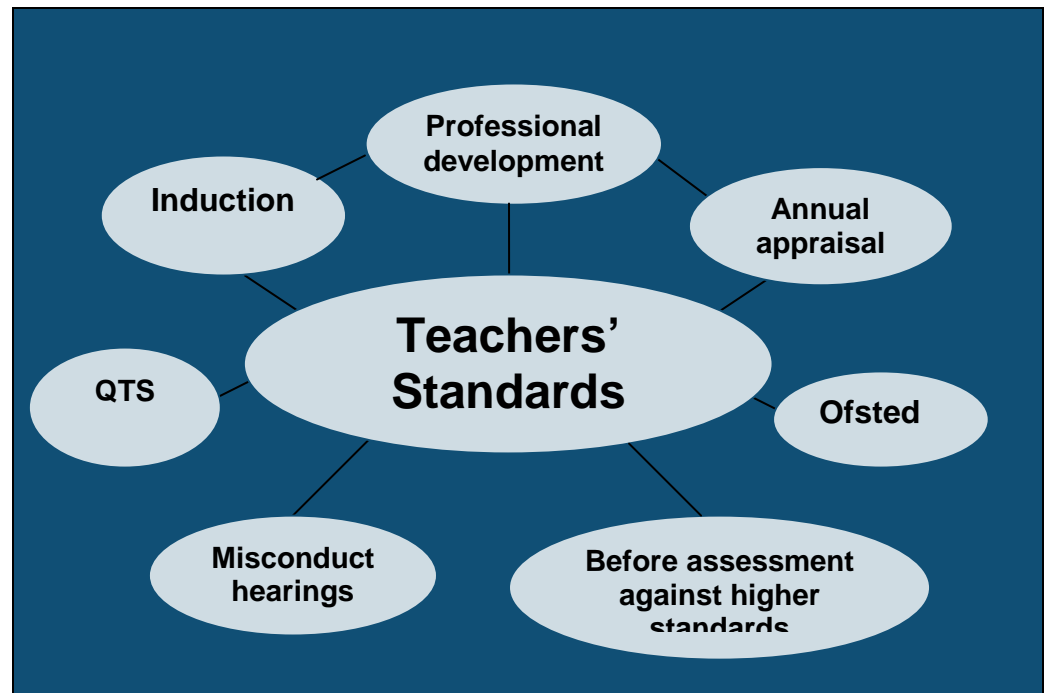
- They can be used by individual teachers to review their practice and inform their plans for continuing professional development.
- The most successful education systems in the world are characterised by high levels of lesson observation. Teachers benefit from observing one another's practice in the classroom. Teachers learn best from other professionals. Observing teaching and being observed, and having the opportunity to plan, prepare, reflect and teach with other teachers can help to improve the quality of teaching.
- Many teachers are keen to improve their own practice by having feedback on their practice from colleagues and from observing the practice of others.

Those involved in training and inducting new teachers will use the Teachers' Standards to ensure quality of new entrants to the profession

- The Teachers' Standards will be used by Initial Teacher Training (ITT) providers to assess when trainees can be recommended for Qualified Teacher Status.
- They will be used by schools to assess the extent to which Newly-Qualified Teachers can demonstrate their competence at the end of their Induction period.

Head teachers and others will use the Teachers' Standards to improve teacher quality, by setting minimum expectations of teaching in their schools and assessing teaching against them

- The Teachers' Standards will be used by maintained schools to assess teachers' performance. They can be used by all schools and teachers to identify development needs and plan professional development.
- Head teachers and other appraisers should use their professional judgement and common sense to assess teachers to a level that is consistent with what should reasonably be expected of a teacher given their role and level of experience.
- Teachers who apply for assessment against post-Threshold, AST and ET standards will be assessed against the Teachers' Standards before being assessed against the higher standards.
- Ofsted inspectors will consider the extent to which the Teachers' Standards are being met when assessing the quality of teaching in schools (including Academies).

The Teaching Agency can use Part Two of the Teachers' Standards when hearing cases of serious misconduct

- Since April 2012, Part Two of the Teachers' Standards can be used by the Teaching Agency when hearing cases of serious misconduct, regardless of the setting where a teacher works.
