Schools Forum – governor representatives needed

Schools' Forum provides an opportunity for schools to contribute to finance strategy in Oxfordshire and to network with other representatives of all sectors of education from nursery to post-sixteen.

The government requires every local authority to set up a schools' forum.

Its purpose is to provide strategic direction for the funding of schools in the local authority and support services in relation to new school funding arrangements

Governor or trustee self-nominations are now requested from the following school types:

- Primary (maintained) 1 governor
- Special (academy or maintained) 1 trustee or governor
- Primary (academy) 1 trustee or governor
- Secondary (academy) 3 trustees or governors

Changes have also been made to bring text on trust-level intervention (formerly financial intervention in academies) into line with the updated academy trust handbook.
