# National Governance Association (NGA) report "Growing Good Governance"

The NGA has published a new report regarding the state of governance practice based on an analysis of external reviews of governance (ERG). The report indicates current effective and improving practice with an emphasis on moving forward with proactive and strategic governance and the essential role of skilled professionals on boards.

Based on the findings, Growing Good Governance ends by proposing the following recommendations;

- Prioritise strategic planning
- Strengthen governance structures processes
- High-quality governance support

- Enhance communication and collaboration
- Address capacity challenges

# Is your school's defibrillator registered on The Circuit?

Just under half of the 22,000 schools' defibrillators are registered on the national defibrillator network. This means that the ambulance service cannot see them to direct people to them in an emergency. Please check <u>www.defibfinder.uk</u> to see if your school's defibrillator is registered so that it can be accessed if required. Then go to <u>The Circuit</u> to register it if appropriate.

# The Annual Schedule of Governing Board Business 2024-25


The Annual Schedule of Governing Board Business for the next academic year is being finalised and will be uploaded to the Governor Services page and GovernorHub as soon as it is completed.




# **Oxfordshire Healthy & Active Young People** Conference


