### **Attendance Guidance**

A reminder that a new version of "Working together to improve attendance", the DfE statutory guidance, has been published and will come into effect from 19<sup>th</sup> August.

### **Cyber Security**

Meeting digital and technology standards in schools and colleges was updated in May. These standards are to help schools build cyber resilience through cyber governance, processes and strategy.

The Digital leadership and governance standard sets out that good digital technology governance includes;

- Identifying roles and responsibilities
- Establishing critical processes to manage digital technology and
- Ensuring that up-to-date information is available to support decision making

A digital lead is accountable for this standard and will coordinate and manage the digital technology strategy. The governing body will support and challenge any plans and decisions made on the strategy. At least one governor should undertake cyber security

-To provide the authority and support to drive and embed culture change

-To ensure climate change and sustainability feature on the agenda at key meetings

-To be responsible for succession planning, so that commitment to sustainability endures in the setting

# DfE Consultation – Relationships, Sex and Health Education (RSHE)

The DfE has opened a consultation on its updated draft Relationships, Sex and Health Education Guidance. This is partly in response to an independent review of gender identity services for children (The Cass Review) which was published in April. Its aim is to protect children from inappropriate teaching on sensitive topics and includes proposed age limits on content and a new section on sexual harassment and violence.


# Local Authority Designated Officer (LADO)

Jo Lloyd has outlined the following updates;

- A new definition of Safeguarding (Working Together to Safeguard Children 2023)
- KCSIE 2024 Checklist to ensure all staff read and understand part 1 of the guidance, particularly the technical changes, remind school leaders and governors to read the full guidance and make information accessible to those who speak English as an additional language or who prefer an audio version.
- Ensure schools have appropriate filtering and monitoring systems in place and regularly review their effectiveness.
- Schools should consider carrying out an annual review of their approach to online safety; <u>Online safety in schools</u> <u>and colleges: Questions from the Governing Board (2022)</u> (publishing.service.gov.uk)


### **Conflicts of Interest**

All governors are responsible for declaring and avoiding conflicts of interest. These arise when the personal or pecuniary interests of a governor/trustee in a matter being considered by the governing board may affect, or be perceived to affect, the ability of that governor/trustee to take decisions on the matter that are impartial and in the best interests of the school/trust. Such conflicts of interest should always be acknowledged and declared, and the governor should withdraw from the meeting for that item of business.






