## Keeping Children Safe in Education

The September 2024 version of the keeping children safe in education guidance is now in force, replacing previous versions.

## Single headline Ofsted grades scrapped

Single headline Ofsted grades for schools have been scrapped with immediate effect.

For inspections this academic year, parents will see four grades across the existing sub-categories: quality of education, behaviour and attitudes, personal development and leadership & management.

Where necessary, in cases of the most serious concern, government will continue to intervene, including by issuing an academy order, which may in some cases mean transferring to new management. Ofsted will continue to identify these schools – which would have been graded as inadequate.

If you have a governor vacancy, please register it with Governors for Schools and they will help you to fill that vacancy. This service is free of charge.







#### Teacher Appraisal - guidance for schools (publishing.service.gov.uk)

The key point from this updated guidance is that for the year 2024/25, the requirement for objectives and the appraisal process to lead to performance-related pay outcomes for teachers and leaders will be removed.

However, note that pay decisions for the 2023/24 academic year, which will be taken in September/October 2024, will continue to be based on the requirements for performance related progression as set out in the September 2023 School Teachers' Pay and Conditions Document (STPCD)


#### Clerks' Briefing for Governance Professionals
