

"1.9 In fulfilling their staffing responsibilities the governing body of a maintained school is free to delegate all of its staffing functions as set out in the Regulations1 to the headteacher, one or more governors, a committee established by the governing body, or one or more governors together with the headteacher; with the exception of a small number of specific tasks set out in the Regulations.

1.10 In delegating functions, the governing body must not lose sight of the fact that it continues to retain overall accountability for the decisions made by those to whom the function has been



delegated. As a result it is important that local procedures are reviewed regularly by the governing body; for example, satisfying themselves that the staffing functions are being addressed and the right people are fulfilling these roles on its behalf.

Admissions consultation


The window for consultations on Admissions arrangements is now open. If your school or trust wants to make any changes to the policy, you will need to undertake a 6-week consultation period **before 31**st **January**.



- Whenever you propose changes to your admissions arrangements (unless the changes are are of the exceptions that don't require consultation)
- At least once every 7 years, even if you make no changes

GovernorHub App

We have been advised by GovernorHub that the GovernorHub app is no longer available. It has been replaced by a new, enhanced webapp designed to offer a more interactive and user-friendly experience.

Please download the web-app using the instructions below so you can keep on top of your governance role on a phone or a tablet.



Note - If you're currently using a desktop computer, then you won't be impacted by this latest update. This is only for those users who were using the GovernorHub app on their smartphone or tablet.


If you're logging in via a browser such as Google Chrome or Edge, you should be able to access as normal



The new government is continuing to drive the Wraparound Childcare Programme and its ambition that every primary aged child will have access to before and after school (8am – 6pm) childcare provision on or near to their school.

'We expect all schools to have wraparound childcare on school site unless there is a reasonable justification not to, having considered all support available. Provision may be run by the school or a PVI provider.

'You are expected to work with your local authority wraparound lead, and childcare providers in your area, to support parents to access quality wraparound childcare.' Wraparound childcare guidance for schools

Grant funding is available to help with the startup and running costs of new or extended provision that meets the government criteria, for up to two years while demand is being built. This helps to remove financial risk. However, this funding has currently only been committed for provision starting in this financial year (up to April 25).

Free Energy Assessments

Action on Carbon and Energy in Schools (ACES) is offering the last few remaining <u>free energy assessments</u> for county-maintained schools. If you have links to a school, please do share with them this fantastic opportunity to find out how they could be saving energy.



An energy assessment will provide the school with a practical plan to reduce energy waste, including a range of simple, low-cost or no-cost measures such as managing hot water timers or adding insulation to boiler rooms.
