Attendees will be asked to complete a brief assessment after the session to receive the certificate.</i></li> </ul>
Safeguarding in Early Years Foundation Stage <u>GovernorHub</u>	Mon 10 Nov 19:00-20:00	This session is for governors who have <b>reception or nursery aged children</b> , whether you are from a primary school or a maintained nursery school.
